## OFFICIAL CONTEST RULES

1. <u>Promotion Description</u>: The "EMMxUJAM Delilah Remix Contest" ("Contest") begins when officially announced and ends on Sunday, March 31st, 2024, at 11:59pm (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Contest, each entrant ("Entrant") unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of UJAM Music Technology GmbH ("Sponsor" or "UJAM"), which shall be final and binding in all respects.
